1. Te Kaupapa | Purpose

E tono ana a Te Punanga Ora i ngā whakaaturanga whakaaro me ngā māramatanga mai i ngā rōpū me ngā tāngata whai pūkenga, hei whakawhiti kōrero ki ngā whānau, hapū me ngā hāpori, ā, kia whakamahia aua kōrero hei whakahou i te hauora ki Taranaki.

Te Punanga Ora is calling for Expressions of Interest from experienced individuals or organisations to work alongside whānau, hapū and hāpori. The purpose is to listen deeply to their experiences, understand their needs and aspirations for hauora, and use these insights to help shape meaningful system change.

2. He Kōrero Whakamārama | Background

Te Punanga Ora is the legislated Iwi Māori Partnership Board (IMPB) for Taranaki, established under the Pae Ora (Healthy Futures) Act 2022. Our vision is to uplift hauora for all Māori through whānau-led decision-making, mātauranga Māori, and enduring relationships.

- Provide ongoing support through facilitation, technical assistance, and cultural support as required through the contract period

- Strong capability in qualitative data collection and synthesis
- Ability to develop and use tools, templates and reporting frameworks that reflect both cultural and strategic priorities

- Cultural competence and commitment to Te Ao Māori.
- Strong facilitation, relationship management, and advocacy with a commitment to relational accountability
- Understanding of Te Punanga Ora's strategic vision and hauora equity mission.
